ENGLISH LANGUAGE & LOGICAL REASONING

1. Correct Answer: B

Explanation: The author highlights India-led developing nations demanding enforcement of *legal obligations* under Article 9.1 (to "provide" finance), not mere voluntary efforts.

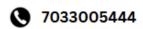
