ENGLISH LANGUAGE & LOGICAL REASONING

1. Correct Answer: A

Explanation: The author's tone combines *disillusionment* (frustration at propaganda-driven complacency) with *diagnostic precision* (a systematic critique of false measures of success). His argument neither mocks nor derides, but dissects the gap between self-perception and actual global relevance.

2. Correct Answer: C

Explanation: The passage's thesis is that *India's supposed rise* — *as amplified by propaganda and numbers* — *is not matched by genuine indispensability in global systems.*

3. Correct Answer: B

Explanation: "Slide into irrelevance" refers to *India's growing disconnection between its internal narrative of progress and the world's objective indifference.*

4. Correct Answer: D

Explanation: DeepSeek is used as a *case* study of India's aspiration contrasted with limited outcomes — revealing the gap between ambition and frontier innovation.

5. Correct Answer: A

Explanation: The author concludes that India's task is "not to be loud but to be necessary," encapsulating the idea that *relevance stems from indispensability, not rhetoric.*

6. Correct Answer: C

Explanation: Declining R&D output supports the argument that India's prominence is exaggerated, reinforcing the claim of limited indispensability.

7. Correct Answer: B

Explanation: The argument presumes *relevance derives from indispensability*, not statistics — implying metrics alone are insufficient.

8. Correct Answer: D

Explanation: A surge in tech exports and AI innovation would *counter* the claim that India is dispensable in global innovation networks.

9. Correct Answer: A

Explanation: The author relies on certain metrics (trade, FDI) to claim overall irrelevance — an instance of *overgeneralisation*, since other parameters (military, cultural soft power) aren't discussed.

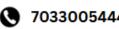
10. Correct Answer: C

Explanation: If India diversifies into key global systems and becomes *structurally indispensable*, the conclusion that necessity trumps loudness holds empirically.









Legal Reasoning

11. B

Explanation - While increasing taxation rates on high-income earners (Option A) and implementing tax incentives for socially responsible initiatives (Option C) are both noble objectives, they may not be sufficient to address the concerns of businesses about the flight of capital from the country. Moreover, increasing taxation rates may also discourage entrepreneurship and innovation. On the other hand, lowering taxation rates on businesses (Option B) may attract more investments and retain capital within the country, which can stimulate economic growth and create job opportunities.

12. A

Explanation - While increasing defense spending may be necessary to strengthen border defenses, it may also escalate tensions with neighboring countries and harm India's diplomatic relations. Decreasing defense spending (Option B) may be counterproductive in addressing security threats, while increasing spending on intelligence gathering and counter-terrorism measures (Option C) may not be sufficient to address the root causes of instability. Instead, increasing diplomatic efforts to reduce tensions and promote cooperation and peace through multilateral forums and negotiations (Option A) may be a more effective and sustainable approach to ensure India's security and stability.

13. D

Explanation - While increasing funding for teacher training and professional development (Option A) and implementing a uniform curriculum (Option B) are both important initiatives, they may not be sufficient to address the gaps in quality of education across different states in the country. Similarly, increasing funding for research and development of educational technologies (Option C) may not address the systemic challenges faced by different states. Instead, implementing a state-specific approach to education reform (Option D) based on the unique needs and challenges of each state, and promoting decentralized decision-making and local participation, may be a more effective and sustainable approach to improve the quality of education in the country.

14. A

Explanation - While increasing spending on building more hospitals and medical facilities (Option B) and increasing funding for research and development of new treatments and medicines (Option C) are important initiatives, they may not address the root causes of poor health outcomes in the country. Similarly, implementing a state-specific approach to healthcare reform (Option B) may not be sufficient to address the systemic challenges faced by different states. Instead, increasing funding for preventive healthcare measures such as vaccination programs and public health campaigns (Option A), and promoting healthy lifestyles and behaviors, may be a more effective and sustainable approach to improve the overall health of the population.

15. A

Explanation - While increasing infrastructure spending may be necessary to improve the country's transportation network and boost economic growth, it should not come at the cost of the environment. Allocating funds for environmental conservation and restoration initiatives (Option D) is important, but it may not be sufficient to address the negative impacts of infrastructure development on the environment. Instead, implementing an environmental impact assessment for all infrastructure projects and ensuring that they meet strict environmental standards (Option A), and prioritizing sustainable and green infrastructure solutions, may be a more effective and sustainable approach to balance the need for infrastructure development with environmental conservation.









16. B

Explanation - In this situation, the member of the committee should not ignore the allegations and must report them to the committee. By sharing the allegations with the rest of the committee and asking for their support, the member can protect themselves from retaliation and ensure that the allegations are investigated in a transparent and responsible manner.

17. A

Explanation - In this situation, the committee should resubmit the report with stronger recommendations and a detailed explanation of why they are necessary. By doing so, the committee can demonstrate the importance of the recommendations and provide evidence to support their position. If the ruling party continues to refuse to accept the recommendations, the committee can consider other options, such as publicly releasing the report to pressure the government or lobbying individual MPs to support the recommendations.

18. C

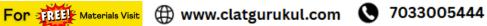

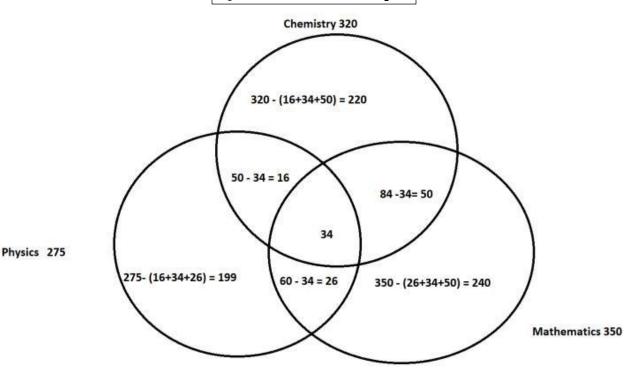
