### **PASSAGE - I**

It was William S. Gaud, administrator of the United States Agency for International Development (USAID), who coined the term "Green Revolution."

In a speech delivered on March 8, 1968, Gaud dwelt on the "paramount importance of the world food problem" and how countries such as India were addressing it through the planting of high-yielding varieties of wheat.

This development, he said, had the makings of a new revolution: "It is not a violent Red Revolution like that of the Soviets...

I call it the Green Revolution."

It's the same USAID that has been shut down by the Donald Trump administration in July. Among the institutions impacted by the closure of the agency — that oversaw civilian foreign aid and development assistance from the US government — is the Mexico-headquartered International Maize and Wheat Improvement Center (CIMMYT).

Synonymous with the renowned agricultural scientist Norman Borlaug, CIMMYT bred the semi-dwarf varieties Lerma Rojo 64A, Sonora 63, Sonora 64, and Mayo 64 that Indian farmers first sowed in 1964–65. Over the next few years, these varieties spread to new countries, laying the foundations of the world's "Green Revolution."

While CIMMYT and its sister body — the International Rice Research Institute (IRRI) — have continued to function with support from the World Bank-funded Consultative Group on International Agricultural Research (CGIAR), USAID had been among their main financiers.

CIMMYT is now looking to India for help. Its Director General, Bram Govaerts, was in New Delhi recently, seeking "stronger and long-term support" from the Indian Council of Agricultural Research (ICAR) and other public agencies.

According to him, the end of US federal funding presents both a challenge and an opportunity for countries such as India to increase their contributions and gain a greater say in shaping CIMMYT's agenda.

Both were key to the US cultivating soft power and projecting a positive global image during the Cold War. That was the time the US saw the Soviet Union as a rival bent on spreading communism to developing countries. The Green Revolution served as America's "non-violent" weapon against hunger and instability.

The irony now is that the very agency which symbolized that partnership — USAID — has itself been dismantled by a US administration increasingly turning inward.

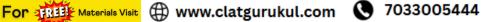
For India, the development opens up a historic opportunity to repay the "Green Debt" owed to the international scientific institutions that helped it transform from a ship-to-mouth economy to a net exporter of grains.

#### **How India Benefited**

The Indian Green Revolution story is inseparable from CIMMYT and IRRI. Their high-yielding varieties, released for commercial cultivation by Indian scientists between 1967 and 1968, boosted wheat and rice productivity exponentially.









Among these, the varieties Kalyan Sona and Sonalika released by M. S. Swaminathan's team at the Indian Agricultural Research Institute (IARI), New Delhi, were particularly impactful. They were derived from CIMMYT material and produced yields of 4–4.5 tonnes per hectare — compared to 1–1.5 tonnes from the earlier tall Indian wheats.

Under the leadership of scientists like B. P. Pal, C. Subramaniam, and Norman Borlaug, India achieved self-sufficiency in wheat production by the early 1970s.

Over time, Indian scientists led by the same IARI and ICAR institutions released many improved descendants of these original semi-dwarf varieties, including HD 2967 and HD 3086, both of which continue to dominate wheat fields.

The table published with the article lists the top 10 wheat varieties cultivated in India — from DBW 187 (2019) to PBW 826 (2022) — together covering more than 20 million hectares, most derived from CIMMYT-linked germplasm.

### **Why India Matters Now**

CIMMYT's director stated that with USAID gone, developing nations such as India, China, and Brazil must shoulder greater responsibility for global agricultural research and food security.

Given India's stature as both a beneficiary and now a donor in several international collaborations, extending more robust funding to CIMMYT is both an act of gratitude and strategic investment.

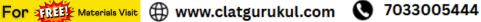
Indian institutions, particularly IARI, ICAR, and state agricultural universities, now have an opportunity to play a guiding role in the next stage of crop improvement — not merely as recipients but as co-architects of global agricultural science.

# LEGAL REASONING

#### **PASSAGE - I**

When one person signifies to another person his willingness to do or not do something (abstain) to obtain the assent of such person to such an act or abstinence, he is said to make a proposal or an offer. In general terms, offer ensues when one party expresses his intention to another party to obtain the consent of the other party to do or not to do such an act and abstinence. To create a lawful contract it must be communicated, section 4 of the Act states that when the proposal comes in the knowledge of a person for whom it is made then such proposal is said to be communicated. A social invitation is not considered to be an offer as such an invitation doesn't create legal relation. It is only an invitation to offer and not an actual offer. Acceptance of an offer must result in a valid contract and such acceptance shall give rise to legal relation. The offer should be clear and definite.

In contract, after having an offer, acceptance should be there by the other party to constitute Agreement. Section 2(b) of the Act defines acceptance when the person to whom the proposal is made gives his consent to such an offer, the offer is said to be accepted. The offer should be accepted unconditionally by the offeree to whom the offer is made, only then it will amount to acceptance. When the offer is accepted it becomes a promise and constitutes agreement. There must be consensus-ad-idem (meeting of minds), i.e., the promisor and promisee must be thinking of the same thing in the same sense while offering and accepting the proposal.

Acceptance can be in the expressed form or implied form. If the parties are negotiating or discussing the agreement then it is not said to be accepted. Acceptance must be in a reasonable amount of time and must be communicated to offeror; mere silence will not amount to acceptance.

Section 4 of the Act states when the acceptance is said to be completed. Acceptance is said to be complete when it comes into the knowledge of the offeror. Before the communication of acceptance is completed the promisor can revoke the acceptance but not after the communication of such acceptance is completed.

11. Sanya sends an email to Rohan offering to sell her iPad for ₹40,000, asking him to confirm "by Monday evening." Rohan reads the email but doesn't respond. 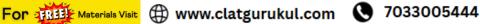

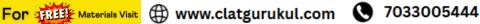
In contracts, it is through communication that a party can initiate an offer to which the other can either accept or simply reject, or can also place their offer. Section 3 and 4 of the Indian Contract Act, 1872 deals with the communication, acceptance and revocation of proposals and when the communication is complete respectively.

Communication can be divided into two types i.e., oral communication and written communication. Oral communication can only occur when the offer and acceptance is done completely on the oral or verbal basis. An oral acceptance is communicated when the offeror hears and understands about the offer. A written communication happens only when the offeror and the offeree communicate the intention to offer or accept through a written form. A written communication happens only when the offer and acceptance, both are in the written form, i.e. either through a mail or telefax.

Now oral communication can be further divided into two (1) personal communication and (2) telephonic conversation. A personal level communication can be done when the offeror and the offeree are sitting next to each other and hence communicating their offers and acceptances. In a telephonic type of oral communication, as the name suggests, the communication is completed through the telephone. For example, C calls up D and tells him that he will sell the book for Rs. 200 and D accepts it in the same telephonic conversation or accepting it some other time.

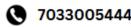

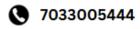

# GENERAL KNOWLEDGE

## Passage-I

India's biotechnology ecosystem is undergoing a major transformation through the launch of the BioE3 (Biotechnology for Economy, Environment and Employment) Policy, officially approved by the Union Cabinet in August 2024. The policy is designed to interlink biotechnology with economic growth, environmental sustainability and job creation, thus aligning with India's goals of green growth, self-reliance and the vision of "Viksit Bharat 2047".

A key component of this policy is the establishment of the National Biofoundry Network (NBN), launched in August 2025. The network links six premier institutions and is intended to provide an end-to-end platform—from design and prototyping to scaling up biomanufacturing—for innovations in synthetic biology, gene editing, climate-smart agriculture, carbon capture, bio-based materials and more.

Under the BioE3 framework, "Bio-Enablers" such as Bio-AI Hubs, Biomanufacturing Hubs and Biofoundries are to be created. The policy emphasises convergence of biotechnology with engineering, AI and digital technologies, and fosters a circular bioeconomy. The DBT (Department of Biotechnology) under the Ministry of Science & Technology serves as the nodal agency.

India's bioeconomy has reportedly grown from about USD 10 billion in 2014 to USD 165.7 billion in 2024, with the goal of reaching USD 300 billion by 2030. Six the matic verticals have been identified: bio-based chemicals & enzymes; functional foods & smart proteins; prec<mark>ision biothe</mark>rapeutics; climate-resilient agriculture; carbon capture & utilization; marine & space biomanufacturing.

The policy also signals India's intention to transition from being research-led to manufacturing-led in biotechnology, enabling start-ups, MSMEs and academia via shared infrastructure, incubation support and scale-up facilities. The BioE3 Challenge for Youth is another initiative under this policy, inviting students, researchers and startups to design "microbes, molecules & more" for solutions in health, agriculture, environment and industry.

However, significant challenges remain: regulatory clarity for advanced biotech (e.g., gene editing, synthetic biology), institutional coordination across ministries, funding and scale-up bottlenecks, and building skilled manpower. These are crucial for translating the policy's promise into real-world impact and for delivering the ambitious bioeconomy target.

In summary, the BioE3 Policy and the National Biofoundry Network together represent India's strategic pivot towards a high-performance bio-manufacturing economy where biology, digital tech and engineering converge—catalysing innovations, generating employment and contributing to sustainable development.

# Passage - II

India's maritime strategy has recently incorporated an innovative initiative known as the Blue Ports Framework, aimed at transforming the nation's fishing-harbour infrastructure into sustainable, smart and inclusive hubs that support the Blue Economy. Launched under the aegis of the Food and Agriculture Organization (FAO) Technical Cooperation Programme (TCP) in collaboration with the Department of Fisheries (DoF), Ministry of Fisheries, Animal Husbandry & Dairying (MoFAHD) of the Government of India, the framework is designed to upgrade key fishing harbours through advanced technology, environmental stewardship and stakeholder inclusion.

Under the Blue Ports Framework, three pilot "Smart & Integrated Fishing Harbours" have been approved — at Vanakbara (Diu), Jakhau (Gujarat) and Karaikal (Puducherry) — with a combined investment of approximately ₹ 369.80 crore. The core objective is to integrate smart technologies (such as IoT-sensor networks, satellite communication, AI/5G platforms and real-time analytics) with eco-friendly infrastructure (rainwater harvesting, energy-efficient lighting, electric equipment, waste/sewage treatment and marine-debris clean-up).

The framework emphasises economic viability, ecological sustainability, and social inclusion — recognising that fishing harbours are not merely physical infrastructure but strategic gateways in the aquatic value chain, connected to food-andnutritional security, livelihood generation and exports. Support is provided under flagship schemes such as the Pradhan Mantri Matsya Sampada Yojana (PMMSY) and the Fisheries and Aquaculture Infrastructure Development Fund (FIDF).

The Blue Ports Framework promises improved post-harvest efficiency, enhanced traceability, higher export competitiveness and more resilient coastal livelihoods. For instance, the FAO-TCP aligns the capacity-building of public and private stakeholders, and draws less ons from successful global case studies such as the Port of Vigo (Spain). Yet, the initiative also faces significant challenges: widespread infrastructure gaps in Indian fishing harbours (e.g., high postharvest loss rates), limited cold-chain and waste-treatment facilities, lack of universal digital monitoring, and the need for climate-resilient design across India's 2.02 million km<sup>2</sup> exclusive economic zone (EEZ).

In summary, the Blue Ports Framework marks India's attempt to integrate maritime infrastructure, coastal livelihoods and sustainability within the broader Blue Economy agenda. By turning traditional fishing harbours into smart portals of value creation and resilience, the programme seeks to deliver enhanced economic returns, better environmental outcomes and stronger socially inclusive systems.

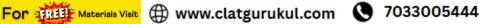

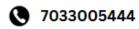
