ENGLISH LANGUAGE & LOGICAL REASONING

1. Correct Answer: B

2. Correct Answer: C

- 5. Global AI Governance

"Global Trade and Digital Commerce" is not mentioned.

3. Correct Answer: B

4. Correct Answer: C

Explanation: The passage narrates examples:


8. Correct Answer: B



Legal Reasoning

- **11. Ans. (a)** Ritik is not on duty and is acting voluntarily while helping out Ajit. The act was in good faith and therefore can claim defence of a good Samaritan. Therefore, option (a) is the most appropriate answer.
- **12. Ans.** (a) The protection is available to people who do not receive reward for the help but here Usha is receiving stipend to help out the Railways. Therefore, option (a) is the most appropriate answer.
- **13. Ans. (c)** Usha is a registered volunteer and is acting out of her own will to help people without any favour and therefore can claim protection under good Samaritan. Therefore, option (c) is the most appropriate answer.
- **14. Ans. (b)** Suit will succeed as Singh did not take license for cab aggregator service. Option (a) does not give a legal backing to the answer. Therefore, option (b) is the most appropriate answer.
- 15. Ans. (c) As per the new law, services rendered during golden hour can be recovered from the government as is the case here. All the other options are out of context. Theus, option (c) is the right answer.
- **16. Ans. (b)** The contract has been given by the State Government for the purpose of a survey. Hence, it will also be the recipient of such data. And the State Government is a 'public authority' by all means. Therefore, the application shall be made before the PIO appointed by the concerned department of the government of SabkaDesh.
- 17. Ans. (c) The request in this situation is before a private company which cannot be deemed to be a 'public authority' in terms of the Act. Hence, Amit & Shah Bros. is not obliged to disclose any data.
- **18. Ans. (d)** The only derivation we can make from the decision of the Supreme Court is that Amit & Shah Bros. will be considered 'State', and therefore a 'public authority' under the terms of the RTI Act. Statement II is not true as public authorities are not expected to disclose any information upon the receipt of an RTI application. Statement III is not derivable from the information provided in the passage.
- **19. Ans. (c)** None of the above bodies satisfies the definition of 'public authorities' stated in the RTI Act. Refer to the lines, "'Public authorities' include bodies of self-government established under the Constitution, or under any law or government notification. For instance, these include Ministries, public sector undertakings, and regulators. It also includes any entities owned, controlled or substantially financed and non-government organizations substantially financed directly or indirectly by funds provided by the government."









20. Ans. (a) As per the passage, public authorities are required to make disclosures on various aspects of their structure and functioning. This includes: (i) disclosure on their organization, functions, and structure, (ii) powers and duties of its officers and employees, and (iii) financial information. Now, it can be argued that monthly remuneration would fall under the head of 'financial information', however the same cannot be stated with absolute certainty because the ambit of 'financial information' has not been explained.

General Knowledge


